

Child Trust Fund to Junior ISA transfer form

This is an application form to transfer an existing Child Trust Fund (CTF) to a Junior ISA with AJ Bell Youinvest. Please note that you must first open a Junior ISA online at www.youinvest.co.uk before you complete this transfer form. The whole CTF will be transferred to the Junior ISA and the CTF will then be closed. The AJ Bell Youinvest Junior ISA is a stocks and shares Junior ISA.

Only the registered contact of the CTF can complete and sign this transfer form. Please note that if anyone other than the registered contact signs this form, the transfer will be declined by the current CTF provider.

If the transfer from the CTF is not successful, any Junior ISA that has been opened on a provisional basis to accept the transfer will be invalid, and any subscriptions to the provisional Junior ISA will be returned. The CTF will remain intact.

If you are considering transferring investments to us as part of this transfer, we recommend you contact your current CTF provider and ask if this is possible. If the CTF provider cannot transfer the investments, they may sell them and transfer as cash instead.
