

Family linking application form

This form lets family members with AJ Bell Youinvest accounts appoint an Account Lead and link their account to them. Each linked family member can grant 'view only' or 'dealing' access to the Account Lead. There can only be one Account Lead per linked family group, and you can only link to one Account Lead at any given time.

Keep in mind the Account Lead can't be a financial adviser acting in a professional capacity on your behalf.

One type of account you won't be able to include in family linking is Junior ISAs. That's because a Junior ISA can be managed only by the parent or legal guardian (the 'registered contact') who opened the account – who will already have full access to it.

Before we grant linked access, we'll verify the arrangements by sending a secure message to each linked customer listed on this form.
